These are identified on parking signage and include The West Pier, Old Harbour Car Parks, Crofton Bridge Road, Ferry Terminal Underground Car Park, The Carlisle Pier and the covered area opposite the RNLi. Vehicles with Annual Permits parked elsewhere within the Harbour will be clamped unless they display an appropriate Pay and Display parking ticket.

| 1 | The issue of an annual parking permit allows individuals to park private vehicles in designated parking zones within the boundaries of Dun Laoghaire Harbour Company (DLHC) and are issued subject to space being available. Vehicles are only to be parked in designated parking zones. The permit is only valid for one year. Any vehicle found to be incorrectly parked may result in the following:<br>a) Permanent withdrawal of the parking permit<br>b) Clamping of the vehicle and the appropriate fine being levied |
| 2 | Permits are non-transferable and must be affixed to the windscreen where they can best be seen. Permits will become void if removed.   |
| 3 | Should a replacement permit be required for whatever reason, the old permit must be returned, otherwise the full fee will apply.   |
| 4 | Permit holders are advised that whereas permission has been given to park in designated parking zones within the Harbour area, DLHC will not accept responsibility for, or be liable for, any damage to, or loss of, any vehicle while on Harbour property. Permit holders are therefore advised that parking will be entirely at the owner's risk.  |
| 5 | Permits applicants should sign acceptance of the above conditions and return the completed application form to:<br><b>The Operations Manager, Dun Laoghaire Harbour Company, Harbour Lodge, Crofton Road, Dun Laoghaire.</b>   |
| 6 | The parking of Camper Vans is restricted to the West Harbour car parks only.   |
